

Homeless - To - Home Program

Are you currently unhoused and need Rental Assistance to MOVE into Housing?

For eligible clients, the **Homeless 2 Home (H2H)** program offers a voucher that will be issued directly to your landlord, providing up to \$1,000 in assistance. To qualify for this voucher, you must meet all the program's eligibility requirements and submit all the necessary documentation.

To apply for the H2H program, please ensure you meet the following eligibility requirements:

- 1. **Current Homelessness:** You are currently experiencing homelessness, which we define as; couch surfing and do not want to be, living in your car, or living on the streets, our organization considers you homeless.
- 2. **Employment Status:** You are currently employed and have been with your current employer for at least 30 days.
- 3. **Minimum Income:** You must earn a minimum of \$1,100 per month from employment income only. Income must come from working a job—benefits, disability payments, unemployment, or any other non-employment income will not be accepted.
- 4. **Maximum Income:** you can earn no more than \$3,000 per month after all/any deductions have been taken out.
- 5. **Completion of Required Courses:** These courses do not expire. If you are not approved at this time, you may reapply in the future using the same certificates.
 - Independent Living Preparation Course: During this course, you will create a budget showing that, if placed into housing, your income exceeds your expenses. This budget must be submitted as part of your documentation.

 - o **Financial Literacy and Career Readiness Course:** In this course, you will create a resume and cover letter, both of which must be submitted with your application.

6. Required Documentation:

- o **Certificates of Completion** for both the Independent Living Preparation Course and the Financial Literacy and Career Readiness Course.
- o Government issued identification, must be current and not expired.
- o Completed H2H Application
- o **30 days of** paycheck stubs to verify your income.
- Budget created during the Independent Living Preparation Course, demonstrating that your income exceeds your expenses if placed into housing.
- o **Resume and Cover Letter** created during the Financial Literacy and Career Readiness Course.
- o **Complete Lease Agreement:** You must submit all pages to the approved lease agreement, signed by all parties (leasing agent and the tenants). This must be permanent housing, no weekly, monthly, or transitional housing will be accepted. Subleasing does not qualify, all lease agreements must be from the property owner or leasing agency.

These requirements are designed to ensure that you are put in a position to succeed upon placement. We are here to support you every step of the way and look forward to assisting you on your journey to stable housing.

Homeless -2- Home Application Checklist

Before submitting your application, please ensure that you have all the items listed on the checklist below. Only when all items are completed and submitted will your application be considered.

Proof of Identification:

□ Copy of your current driver's license or current government identification

Proof of Current Employment:

□ Four most recent pay stubs showing at least \$1,100 in monthly income.

Certificates of Completion:

- □ Certificate of completion for the **Independent Living Preparation Course**.
- □ Certificate of completion for the **Financial Literacy and Career Readiness Course**.

Budget Plan:

Budget created during the **Independent Living Preparation Course** showing that your income exceeds your expenses if placed into housing.

Resume and Cover Letter:

□ Resume and cover letter created during the **Financial Literacy and Career Readiness Course**.

Housing Documentation:

□ Complete approved lease agreement showing your secured housing.

Important Note:

You must ensure that **ALL** items on this checklist are complete before submitting your application. Incomplete applications will not be considered, and we will only review submissions that include all necessary documentation and meet the program's requirements.

Please use this checklist as a guide to ensure that your application is complete and ready for submission.
